## TERMS OF SERVICE

Please read these Terms of Service (the "<u>Agreement</u>") carefully. Your use of (including any access to) the Service (as defined below) constitutes your consent to this Agreement.

This Agreement is between you and Consolidated Edison Company of New York, Inc. ("<u>Con Edison</u>" or "<u>we</u>" or "<u>us</u>") concerning your use of (including any access to) the Smart Energy Plan site currently located at <a href="https://www.conedisonsmartenergyplan.com/enroll">https://www.conedisonsmartenergyplan.com/enroll</a> (together with any materials and services available therein, and successor site(s) thereto, the "<u>Service</u>").

BY ACCESSING OR USING THE SERVICE, YOU AFFIRM THAT YOU ARE OF LEGAL AGE TO ENTER INTO THIS AGREEMENT.

IF YOU ARE AN INDIVIDUAL ACCESSING OR USING THE SERVICE ON BEHALF OF, OR FOR THE BENEFIT OF, ANY CORPORATION, PARTNERSHIP OR OTHER ENTITY WITH WHICH YOU ARE ASSOCIATED (AN "ORGANIZATION"), THEN YOU ARE AGREEING TO THIS AGREEMENT ON BEHALF OF YOURSELF AND SUCH ORGANIZATION, AND YOU REPRESENT AND WARRANT THAT YOU HAVE THE LEGAL AUTHORITY TO BIND SUCH ORGANIZATION TO THIS AGREEMENT. References to "you" and "your" in this Agreement will refer to both the individual accessing or using the Service and to any such Organization.

1. Changes. We may change this Agreement from time to time by notifying you of such changes by any reasonable means, including by posting a revised Agreement through the Service. Any such changes will not apply to any dispute between you and us arising prior to the date on which we posted the revised Agreement incorporating such changes or otherwise notified you of such changes.

Your access to or use of the Service following any changes to this Agreement will constitute your acceptance of such changes. The "Last Updated" legend above indicates when this Agreement was last changed. We may, at any time and without liability, modify or discontinue all or part of the Service (including access to the Service via any third-party links); charge, modify or waive any fees required to use the Service; or offer opportunities to some or all Service users.

- **2. Information Submitted Through the Service**. You represent and warrant that any information you provide in connection with the Service is and will remain accurate and complete, and that you will maintain and update such information as needed.
- **3. Jurisdictional Issues**. The Service is controlled or operated (or both) from the United States, and is not intended to subject Con Edison to any jurisdiction or law other than the State of New York. The Service may not be appropriate or available for use in some jurisdictions outside of the State of New York. Any access to or use of the Service is at your own risk, and you must comply with all applicable laws, rules and regulations in doing so. We may limit the Service's availability at any time, in whole or in part, to any person, geographic area or jurisdiction that we choose.
- **4. Smart Energy Plan**. The Service may allow you to confirm your participation in Con Edison's Smart Energy Plan. By using the Service to confirm your participation, you represent and warrant that you are

authorized to do so with respect to the applicable Con Edison account, and, if applicable, that you meet any other eligibility criteria for such participation. You acknowledge that the Smart Energy Plan is being made available as a pilot program of Con Edison for a limited time period, and we may change or discontinue the Smart Energy Plan at any time. However, we will provide you with notice of changes affecting your Con Edison account that result from any change or discontinuation of the Smart Energy Plan. ## **5. Rules of Conduct**. In connection with the Service, you must not:

- Post, transmit or otherwise make available through or in connection with the Service any materials that are or may be: (a) threatening, harassing, degrading, hateful or intimidating, or otherwise fail to respect the rights and dignity of others; (b) defamatory, libelous, fraudulent or otherwise tortious; (c) obscene, indecent, pornographic or otherwise objectionable; or (d) protected by copyright, trademark, trade secret, right of publicity or privacy or any other proprietary right, without the express prior written consent of the applicable owner.

- **6. Registration**. You will not be required to create any user name or password in order to access or use the Service. However, you may need to register and provide certain information in connection with accessing or using the Service. You acknowledge and agree that we are not responsible for any action or omission, whether by physical, automated or electronic means, that is performed using or in connection with such information.
- 7. Feedback. You represent and warrant that you have all rights necessary to grant the licenses granted in this section, and that your Feedback, and your provision thereof through and in connection with the Service, is complete and accurate, and is not fraudulent, tortious or otherwise in violation of any applicable law or any right of any third party. You further irrevocably waive any "moral rights" or other rights with respect to attribution of authorship or integrity of materials regarding any Feedback that you may have under any applicable law under any legal theory.

- **8. Monitoring**. We may (but have no obligation to) analyze your access to or use of the Service. We may disclose information regarding your access to and use of the Service, and the circumstances surrounding such access and use, to anyone for any reason or purpose.
- **9. Your Limited Rights**. - 15. Termination. This Agreement is effective until terminated. Con Edison may terminate or suspend your access to or use of the Service at any time and without prior notice, for any or no reason, including if Con Edison believes that you have violated or acted inconsistently with the letter or spirit of this Agreement. Upon any such termination or suspension, your right to access or use the Service will immediately cease, and ConEdison may, without liability to you or any third party, immediately delete any information you submitted through the Service, all Feedback, and all associated materials, without any obligation to provide any further access to such information, Feedback and materials. We may assign, transfer or sublicense any or all of our rights or obligations under this Agreement without restriction. No waiver by either party of any breach or default under this Agreement will be deemed to be a waiver of any preceding or subsequent breach or default. Any heading, caption or section title contained herein is for convenience only, and in no way defines or explains any section or provision. All terms defined in the singular shall have the same meanings when used in the plural, where appropriate and unless otherwise specified. Any use of the term "including" or variations thereof in this Agreement shall be construed as if followed by the phrase "without limitation." This Agreement is the entire agreement between you and Con Edison relating to the subject matter hereof, and supersedes any and all prior or contemporaneous written or oral agreements or understandings between you and Con Edison relating to such subject matter. Notices to you (including notices of changes to this Agreement) may be made via posting to the Service or by e-mail (including in each case via links), or by regular mail. Without limitation, a printed version of this Agreement and of any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to this Agreement to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form. Con Edison will not be responsible for any failure to fulfill any obligation due to any cause beyond its control.
